HISTORY, BACKGROUND and DISCUSSION

This Plan will allow the Brownfield to reimburse 50 West Michigan Ave., LLC for the costs of eligible environmental and non-environmental activities needed to safely redevelop one tax parcel at 50 W. Michigan Avenue into an 18,000 square-foot rock climbing gym that will include climbing walls for beginners to advanced climbers and space for other fitness activities. The Project will include lead and asbestos abatement, interior and exterior demolition activities, site preparation activities and environmental activities.

The Project is expected to commence in 2020 and be completed in 9 to 12 months. Total capital investment is estimated at approximately \$4 million. The Project is expected to generate approximately five full-time and part-time jobs. The Brownfield Plan, if approved, provides for the use of tax incremental financing, to reimburse 50 West Michigan Ave., LLC.
